

**ANNEXURE 2  
TO THE CONSITUTION OF ROBINA BRAVES BASEBALL CLUB INC**

**Amendment of Constitution  
by special resolution dated 27<sup>th</sup> May 2026**

***Revised rules:***

**Rule 7 Application for Membership**

- (1) A person **cannot be admitted as a member** of the association unless the person—
  - (a) **makes a written application for membership**, and
  - (b) the **application is approved at a meeting** of the management committee.
- (2) The written application must—
  - (a) be signed by the applicant and the applicant's proposer and seconder, and
  - (b) be in the form decided by the management committee.

**Rule 38(8):**

- (8) The following members are **not entitled to vote** at any meeting of the association:
  - (a) temporary members,
  - (b) honorary members,
  - (c) members who are minors (under 18 years of age).

**Rule 32(2)(b)**

(b) receiving a **written report by the association president** of the association's operations throughout the year;

**Rule 48**

The end date of the association's financial year is **June 30** in each year.

***Additional Rule:***

**Rule 50 List of Reciprocal Clubs**

The secretary must keep on the club premises a list of all clubs with which the association has reciprocal membership arrangements.

***Revised Rule:***

**Rule 5 Classes of members**

(1) The membership of the association consists of ordinary members, and any of the following classes of members—

- fee paying senior players,
- parents of fee paying junior players,
- social members,
- **life members.**

(2) The number of ordinary members is unlimited.

(3) Social membership fees shall be due and payable upon application for social membership in accordance with adopted fee schedules.

**(4) Life Membership may be granted to any person who has rendered distinguished or special service to the association.**

- (a) A nomination for Life Membership must be submitted in writing to the management committee by two financial members.
- (b) The management committee must consider the nomination and, if supported, present it to the next annual general meeting for approval.
- (c) Life Membership is conferred only by a resolution passed by at least a two-thirds majority of members present and entitled to vote at a general meeting.
- (d) A Life Member is exempt from payment of membership fees but has all the rights and privileges of an ordinary member.

***Insert after Rule 5 as new Rule 5A:***

**5A Life Membership**

(1) The association may award Life Membership to individuals in recognition of outstanding service to the association.

(2) Nominations for Life Membership must:

- (a) be submitted in writing to the management committee; and
- (b) include details of the nominee's service and contribution to the association.

(3) The management committee must consider all nominations and may endorse nominees for Life Membership.

(4) Any endorsed nominee must be submitted to the next Annual General Meeting for consideration.

(5) A nominee will be granted Life Membership only if approved by a majority vote of members present and eligible to vote at the Annual General Meeting.

(6) Life Members will have the rights and privileges determined by the association, including any exemptions or benefits as approved at a general meeting.
